# 2018 Pro Bono Highlights

### **Veteran's Claim to Benefits**

Coblentz attorneys represented a Vietnam army combat veteran in his appeal before the Court of Appeal for Veterans Claims (CAVC) for service-connected benefits for PTSD. Our client claimed he was entitled to 100% disability payments from at least the date he had been forced to stop working because of his PTSD. The VA disagreed, insisting instead that he only became 100% disabled much more recently, ignoring substantial evidence to the contrary. In conjunction with Swords to Plowshares, we appealed to the Court of Appeal for Veterans Claims and obtained a reversal and remand of the VA's decision. This remand order recovered a substantial settlement of retroactive benefits for the veteran, depending on the VA's determination of the claim's effective date.

# **Victory for Young Immigrant**

Coblentz attorneys represented a young woman from Central America in a Federal Tort Claims Act case filed in coordination with the American Civil Liberties Union (ACLU) of Northern California. The plaintiff alleged she was assaulted by a U.S. Border Patrol agent while being held in the Border Patrol's custody. Coblentz and the ACLU obtained a six-figure settlement for the client, who plans to use the money to attend college in California.

# **Clinics for Local Nonprofits**

Coblentz hosted a facilities and real estate training for Bay Area nonprofits in conjunction with the Justice & Diversity Center (JDC) as a component of its "Community Organization Representation Project" or CORP. We also hosted a follow up clinic attended by five local nonprofits, which also served an intake function for the JDC in evaluating eligibility and need for placement of the nonprofits with full scope pro bono representation.

#### **GTMO Trial Observations**

A Coblentz partner traveled for a second time to Guantánamo Bay as a civilian observer and member of the Pacific Council on International Policy's GTMO Task Force, to observe the hearings in the *United States v. Khalid Shaikh Mohammed ("KSM")*, et al. The hearings involved key issues of whether defense counsel would be permitted to conduct their own investigation into the interrogation and torture of defendants. This evidence could be crucial to determining the credibility of witnesses and evidence at trial, and would be used as mitigating evidence during the sentencing phase of the military trial. The prosecution opposes the request because the investigation would reveal the identity of CIA and other personnel. The Task Force compiles their observations of the trial into reports and recommendations.

#### **Help for Domestic Violence Victim**

Coblentz attorneys won a domestic violence restraining order for a client through the Legal Aid Society of San Mateo County. The restraining order provided our client police protection should her batterer, an ex-boyfriend who had subjected her and her children to physical and emotional abuse for over two years, attempt to contact or come within 100 yards of her.

# **Housing Negotiations**

Coblentz attorneys regularly volunteer for the Housing Negotiation Project, where they represent low-income clients facing eviction. In the past year, we have assisted multiple clients, including helping a family whose primary wage earner is suffering from cancer and no longer working in obtaining a full waiver of back rent plus an additional three months for the family to stay in the home while looking for replacement housing, and helping a tenant to stay in his single occupancy hotel room after he fell behind on rent while recovering from a violent beating and robbery in the Tenderloin.

#### **American Citizen Imprisoned in Egypt**

Coblentz attorneys are representing Moustafa Kassem, an American citizen who has been imprisoned in Egypt since 2013 when he was arrested in Nasr City, Egypt while running an errand during a protest against the military coup. The 52-year-old father and resident of New York has been held for more than four years without any official verdict or sentence. Our representation was mentioned in articles appearing in HuffPost and The Intercept. Citing the press coverage, we convinced Congressman Peter King to request that Vice President Pence raise Mr. Kassem's case during his visit with Egyptian President Abdel Fattah al-Sisi.
