California and Bay Area Construction Orders as of April 22, 2020

On March 19, 2020, Governor Newsom issued a "Safer at Home" Order, which generally permits construction, including housing, to continue statewide. On March 31, 2020, six Bay Area counties – Alameda, Contra Costa, Marin, San Francisco, San Mateo, and Santa Clara – as well as the City of Berkeley, coordinated on and each issued updated local shelter-in-place orders extending and further restricting non-essential activities through May 3, 2020. Local health officers are carefully monitoring the evolving situations in their respective districts and could change local restrictions as necessary. The State may also issue additional guidance. The current statewide Order and orders for Bay Area jurisdictions are linked below. The Coblentz Real Estate Team and authors of Unfamiliar Terrain will continue to monitor these developments.
