Pro Bono Highlights

2020 Pro Bono Award

Rosan Agbajoh: Discrimination Defense

Coblentz attorney Rosan Agbajoh represented a former social worker for Napa County who had pursued a pro se case of racial discrimination, harassment, and retaliation on her own for two years, and was able to negotiate a favorable settlement for the client. For her hard work and strategic thinking on this matter, Rosan was named our 2020 Pro Bono Award winner.

Featured Pro Bono Work

Ensuring Voting Rights are Protected

Coordinating with the Lawyers' Committee for Civil Rights, Coblentz attorneys coordinated and volunteered time for non-partisan election protection efforts leading up to the November election. This election protection work provided critical support during a challenging election. More than 30 attorneys volunteered their time by poll monitoring, both locally and in "swing states," and by staffing regional voter hotlines to answer voter questions and assist with registration, mail-in voting, and other questions.

Supporting Black Lives Matter Protests

Coblentz attorneys and staff assisted the Lawyers' Committee for Civil Rights in their defense of recent Black Lives Matter protests with key research into local ordinances.

Improving Prison Conditions

Coblentz attorneys are representing the Federal Defenders in Alabama in potential litigation of the prison conditions of death row inmates in Alabama state prison. The inmates suffer from horrific conditions, including raw sewage in their cells, and are soon to be moved to a separate, segregated unit that suffers from un-remediated black mold and that likely subjects them to 22 or more hours a day locked in their windowless cells without access to televisions or many personal items. We are working to improve the conditions of their confinement.

Fighting Against Lethal Injection

Coblentz attorneys are working with the American Civil Liberties Union on its challenge to the California lethal injection protocol for implementing the death penalty.

Help for DACA Recipients

Coblentz attorneys participated in a Justice & Diversity Center volunteer program with then-Senator Kamala Harris' office to assist recipients of Deferred Action for Childhood Arrivals (DACA). The program focused on providing one-on-one trainings to DACA recipients on protecting their ability to work in the United States in the face of uncertainty surrounding the DACA program.

Help for Prisoners at Risk for COVID

Coblentz attorneys took on cases for inmates with health conditions whose lives were threatened because of the COVID outbreak in prisons, working to minimize the danger COVID poses to incarcerated individuals.

Supporting A Pandemic Non-Profit

Coblentz attorneys worked to form and obtain tax-exempt status for an organization that works with local businesses to prepare food for distribution to residents most vulnerable during the COVID pandemic. The organization also supports San Francisco small businesses particularly affected by the pandemic, including because of racial-, economic-, or gender-based inequality.

Standing Up for Small Employer Rights

Coblentz attorneys, through the U.S. District Court for the Northern District of California's Justice & Diversity Center, took on representing a small Bay Area electrician in his dispute with a local union over employee benefits, representing the electrician at two settlement conferences.

Supporting Organizations to Support Families

A Coblentz attorney assisted APA Family Support Services in employment-related projects, which ensured proper staff classification and provided an updated employee handbook. The organization promotes healthy children and families by providing family support services to prevent child abuse and domestic violence.
