

He obtained special immigrant juvenile ("SIJ") status and legal permanent residency for a Central American minor, and he represented amici curiae before the Supreme Court of California in support of another Central American minor seeking findings from a California family court in support of her own SIJ application. Dan is a Founding Member and Corporate Partnerships Co-Chair of the Young Professionals Council of the Okizu Foundation, the mission of which is to help all members of families affected by childhood cancer to heal through peer support, respite, mentoring, and recreational programs.

Prior to joining Coblentz, Dan was an associate at Gibson, Dunn & Crutcher LLP and interim regulatory counsel at DoorDash. Before becoming a lawyer, Dan spent seven years as a transplant organ placement coordinator and served on the Ethics Committee of the United Network for Organ Sharing, the not-for-profit quasi-governmental administrator of the U.S. Organ Procurement and

Transplantation Network.

Dan earned his J.D. from the University of California, Berkeley School of Law, where he was elected to the Order of the Coif, served as judicial extern to California Supreme Court Associate Justice Goodwin H. Liu, and received the Jurisprudence Award in Written & Oral Advocacy and the Prosser Prize in Professional Legal Ethics.
